Overview

This appendix provides tables comparing the overlapping 5-year period for the FY26-31 Capital Improvement Program previously approved by the Planning Commission and Board of Estimates with the and the current agency requested program covering the FY27-32 period.

Changes between the two Capital Improvement programs show projects that have been:

- Added to the CIP since the prior CIP
- Removed from the CIP since the prior CIP
- Modified to change the schedule, sources, or allocation amounts (increase or decrease)

The comparison by project request shows differences by revenue source-specific requests so the changes for a single project may appear on multiple lines. Agency staff supported this review process by categorizing each change into one of several change types and providing a brief narrative justification.
